## Review of Plan Revisions:

1 <sup>st</sup> Revision:	Included in the initial fee
2 <sup>nd</sup> Revision:	50% of initial fee
3 <sup>rd</sup> Revision:	75% of initial fee

<sup>\*</sup>Where the applicant or their agent fails to directly address and attempt to resolve concerns expressed by the District after three technical reviews of the E&S plan, a complete resubmission of the original fees (with the exception of the NPDES filing fee) will be imposed for all subsequent E&S plan revisions. In the case of repeated incompleteness results, the application will be denied.

## Amendments and Corrective Action Plan(CAP):

Minor	\$200 per minor modification, made payable to "Beaver County Conservation District"
Major and CAP Requires a new permit submission and all applicable fees for a new submission	

Erosion & Sediment Control Plans associated with General Permits (CHP 105) require an E&S review fee of \$200.00 made payable to "Beaver County Conservation District" for earth disturbance inside the floodway. Any earth disturbance outside of the floodway follows Chapter 102 application and fees.

This application must be completed by the applicant or his agent, submitted with the required plan information, and the required fee(s). Incomplete submissions will not be accepted for review.

The applicant agrees to comply with all the requirements of the Pennsylvania's Erosion and Sedimentation Pollution Control Rules and Regulations, and further agrees to obtain all necessary Federal, State, County, and Local permits associated with the subject project.
